Liability Release Form

I further understand that serious accidents occasionally occur during competition events and training and that participants in skiing and snowboarding activities may sustain mortal or serious personal injury, and/or property damage, as a consequence thereof. Knowing the risks inherent in the activities associated with this entry in the Buckman's Boulder Bash '09, nevertheless, I hereby agree to personally assume those risks. Medical permission is hereby granted for a qualified medical practitioner to perform any operation, administration of anesthetic or blood transfusion as may be deemed necessary or advisable for the treatment of any illness or injury suffered. Officials of the Buckman's Boulder Bash '09 are authorized to sign all medical emergency release documents for such treatment, It is further understood that this waiver, release, and assumption of risk are binding on my heirs and assigns. I further agree to abide by all rules and regulations of the Event Organizers.
